1. Background

- 1. This submission is made by the Local Government and Shires Association of New South Wales ("LGNSW") on behalf of State and Territory Local Government Associations. The submission arises from an application by LGNSW to the Fair Work Commission ("FWC") on 30 August 2017 to vary clause 20.4 of the Local Government Industry Award 2010 ("LGI Award"). Clause 20.4 of the LGI Award deals with default superannuation funds under the award. The submission is also in response to the directions issued by the FWC, which require LGNSW to file submissions in support of its application by 29 September 2017.
- 2. In this submission, Local Government Associations ("**LGAs**") means the following organisations:
 - 2.1 Local Government and Shires Association of New South Wales ("LGNSW")
 - 2.2 Municipal Association of Victoria ("MAV")
 - 2.3 Local Government Association of Queensland ("LGAQ")
 - 2.4 Local Government Association of Northern Territory ("**LGANT**")
 - 2.5 Local Government Association of Tasmania ("LGAT")
 - 2.6 Western Australian Local Government Association ("WALGA"); and
 - 2.7 Local Government Association of South Australia ("LGASA").

2. Introduction

- Default superannuation funds were first inserted into the LGI Award (at clause 20.4) by the former Australian Industrial Relations Commission ("AIRC") in 2009 during stage 4 of the AIRC's award modernisation process, with the consent of all parties involved in the proceedings.
- 4. The list of default superannuation funds referred to in clause 20.4 of the LGI Award was varied by a determination of a Full Bench of the FWC in *Superannuation* 2013 Review (Full Bench, 30 December 2013, PR546113). The variation, which

- took effect from 1 January 2014, deleted references to "City of Melbourne Superannuation Sub Plan (CMSSP)" and "City Super".
- 5. The Full Bench's determination of 30 December 2013 (PR546113) indicates that "City of Perth Superannuation Fund" should also have been deleted from clause 20.4 of the LGI Award, with effect from 1 January 2014. There appears to have been an oversight as the reference to "City of Perth Superannuation Fund" still appears in clause 20.4 of the LGI Award. The "City of Perth Superannuation Fund" no longer exists, is therefore obsolete, and should be deleted in accordance with the Full Bench's previous determination.
- 6. Further changes to the names of the default superannuation funds referred to in clause 20.4 of the LGI Award have occurred in recent years.
- 7. The application seeks to amend clause 20.4 of the LGI Award to reflect recent changes in the names of default superannuation funds and/or to remove obsolete references to the names of superannuation funds which no longer exist.

3. Grounds and reasons (the merits of the application)

General

8. Correcting incorrect references to the names of default superannuation funds and/or removing references to the names of obsolete default superannuation funds in clause 20.4 of the LGI Award is required to ensure that the LGI Award is "easy to understand".

Removal of the reference to 'Quadrant Superannuation Scheme'

9. On 30 November 2015 "Quadrant Superannuation Scheme" merged with "Tasplan". As a result, members of the Quadrant Superannuation Scheme were transferred to the Tasplan fund through a 'successor fund transfer'. Consequently the Quadrant Superannuation Scheme ceased to exist as of 1 December 2015. Tasplan continues to exist as a default superannuation fund for the Local Government industry.

- 10. As the Quadrant Superannuation Scheme now forms part of Tasplan, the reference to "Quadrant Superannuation Scheme" in subclause 20.4(c) of the LGI Award is obsolete and should be deleted.
- 11. Tasplan is a superannuation fund which offers a MySuper product, as set out in the attached Australian Prudential Regulation Authority (APRA) list of superannuation funds offering MySuper products. This list is current as at 7 July 2017.

Removal of the reference to Local Super

- 12. On 1 July 2012 "Local Super" merged with "Statewide Super" with the merged fund using the trading name "Statewide Super". As a result of the merge, members of Local Super were transferred to Statewide Super through a successor fund transfer.
- 13. As Local Super now forms part of Statewide Super, the reference to "Local Super" in subclause 20.4(h) of the LGI Award is obsolete and should be deleted and replaced with a reference to "Statewide Super".
- 14. Statewide Super is a superannuation fund which offers a MySuper product, as set out in the attached Australian Prudential Regulation Authority (APRA) list of superannuation funds offering MySuper Products.

Re-numbering of subclauses in clause 20.4

- 15. If the FWC agrees to delete the reference to "Quadrant Superannuation Scheme" at subclause 20.4(c) of the LGI Award, the remaining subclauses in clause 20.4 should be renumbered so that:
 - Subclause 20.4(d) will become subclause 20.4(c)
 - Subclause 20.4 (e) will become subclause 20.4(d)
 - Subclause 20.4(f) will become subclause 20.4(e)
 - Subclause 20.4(g) will become subclause 20.4(f)

- Subclause 20.4(h) will become subclause 20.4(g); and
- Subclause 20.4(i) will become subclause 20.4(h).

4. Jurisdictional matters

To omit the name of a specified default superannuation fund or specified product that has ceased to exist and another MySuper product is specified in relation to the fund

16. The FWC has power under section 159A(1) of the Act to make a determination varying the default fund term of a modern award in relation to a superannuation fund specified in the term in relation to a standard MySuper product (the "specified product") in the following circumstances:

"

(b) "if the fund has ceased to exist – to omit the name of the fund and the specified product;

. . .

- (d) if the specified product has ceased to exist and another MySuper product is specified in relation to the fund – to omit the name of the fund and the specified product.
- 17. As indicated above, "Quadrant Superannuation Scheme" now forms part of "Tasplan", and "Local Super" now forms part of "Statewide Super". "Quadrant Superannuation Scheme" and "Local Super" no longer exist as superannuation funds in their own right. The FWC therefore has power to make the proposed amendments under section 159A(1) of the Act.

To remove an ambiguity or uncertainty or to correct an error

- 18. The FWC has power under section 160 of the Act to make a determination varying a modern award to remove an ambiguity or uncertainty or to correct an error.
- 19. Correcting incorrect references to the names of default superannuation funds and/or removing references to the names of obsolete default superannuation funds

will remove ambiguity or uncertainty in the LGI Award. The FWC therefore has power to make the proposed amendments under section 160 of the Act.

The modern awards objective

20. The proposed amendments are consistent with the 'modern awards objective' at section 134 of the Fair Work Act 2009 (the "Act"), which requires the FWC to ensure that modern awards, together with the National Employment Standards, provide a fair and relevant minimum safety net of terms and conditions, taking into account:

"...

(g) the need to ensure a simple, <u>easy to understand</u>, stable and sustainable modern award system for Australia that avoids unnecessary overlap of modern awards; ..." (emphasis added)

FWC precedent

21. The FWC has previously amended clause 20.4 of the LGI Award to remove the names of default superannuation funds that no longer exist – see Superannuation – 2013 Review (Full Bench, 30 December 2013, PR546113). The variations sought by the application are therefore consistent with existing FWC precedent.

Variation of a default fund term of a modern award by a single FWC Member under Division 5 of Part 2–3

22. A determination that varies a default fund term of a modern award may be made by a single FWC Member under Division 5 of Part 2–3 (Note: if the variation is made during a 4 yearly review conducted under Division 4A of Part 2–3, the determination must be made by a Full Bench).
