Application to Modern Awards

This letter is in relation to the variation of the superannuation clauses of six modern awards.

Catholic Super requests that Fair Work Australia varying the following six Modern Awards to remove ambiguity and uncertainty:

1. **Aged Care Award 2010 (ID: MA000018)**
2. **Nurses Award 2010 (ID: MA000034)**
3. **Health Professionals and Support Services Award 2010 (ID: MA000027)**
4. **Educational Services (Teachers) Award 2010 (ID: MA000077)**
5. **Educational Services (Schools) General Staff Award 2010 (ID: MA000076)**
6. **Social, Community, Home Care and Disability Services Industry Award 2010 (ID: MA000100)**

In each of the above awards, Catholic Super requests that Fair Work Australia remove any references to 'National Catholic Superannuation Fund' and replace them with 'Catholic Super (CSF)' to reflect the recent merger of the two funds.

In particular, Catholic Super submits that the following variations are necessary to remove ambiguity or uncertainty:

1. **MA000018**: cl 21.4(e) be amended to read 'Catholic Super (CSF)'
2. **MA000034**: cl 20.4(e) be amended to read 'Catholic Super (CSF)'
3. **MA000027**: cl 22.4(e) be amended to read 'Catholic Super (CSF)'
4. **MA000077**: cl 18.4(c) be removed
5. **MA000076**: cl 20.4(c) be removed
6. **MA000100**: cl 23.4(e) be amended to read 'Catholic Super (CSF)'

Catholic Super requests that Fair Work Australia make the determinations for the variations listed above on its own initiative, in accordance with s 160(2)(a) of the Act.
