  2. By deleting the amount “\$12.96” appearing in clause 23.3(d)(ii) and inserting “\$16.20”.
  3. By deleting the amount “\$17.87” appearing in clause 23.3(d)(iii) and inserting “\$22.33”.
  4. By deleting the amount “\$14.10” appearing in clause 23.3(e)(i) and inserting “\$15.20”.
  5. By deleting the amount “\$12.71” appearing in clause 23.3(e)(ii) and inserting “\$13.70”.
  6. By deleting the amount “\$12.55” appearing in clause 23.3(g) and inserting “\$13.11”.
  7. By deleting the amount “\$0.92” appearing in clause 23.3(h)(i) and inserting “\$0.96”.
  8. By deleting the table appearing in clause D.2.1 and inserting the following:
