Expense-related allowances.

- A. Pursuant to s 157 of the *Fair Work Act 2009* (Cth), the above award is varied as follows:
- 1. By deleting the amount "\$19.57" appearing in clause 18.3(a)(i) and inserting "\$20.08".
- 2. By deleting the amount "\$5.17" appearing in clause 18.3(a)(ii) and inserting "\$5.30".
- 3. By deleting the amount "\$19.57" appearing in clause 18.3(a)(iii) and inserting "\$20.08".
- 4. By deleting the amount "\$24.49" appearing in clause 18.3(a)(iv) and inserting "\$25.13".
- 5. By deleting the table appearing in clause 18.3(c)(iii) and inserting the following:

6. By deleting the amount "\$19.67" appearing in clause 18.3(d)(ii) and inserting "\$20.18".

7. By deleting the table appearing in clause C.2 and inserting the following:

| Relieving allowance—meal expenses—total | 18.3(c)(iii) | 120.55 | per occasion |
| Living away from home allowance | 18.3(c)(vi) | 29.86 | per night |
| Incidental expenses allowance | 18.3(d)(ii) | 20.18 | per day |

B. This determination comes into operation on 1 July 2025. In accordance with s 165(3) of the *Fair Work Act 2009* (Cth) this determination does not take effect in relation to a particular employee until the start of the employee's first full pay period that starts on or after 1 July 2025.
