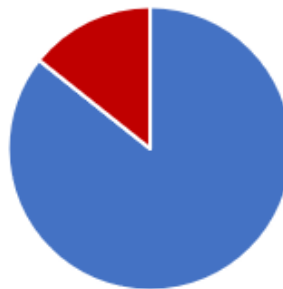

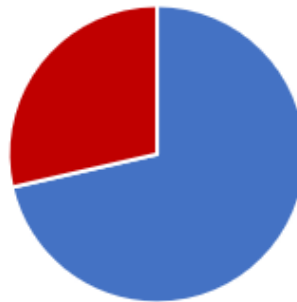

- No - 4 (28.6%)

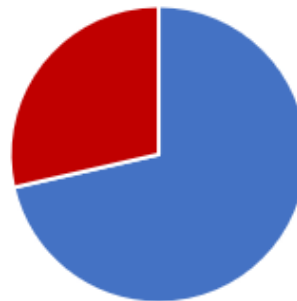


Question 10

- No - 4 (28.6%)

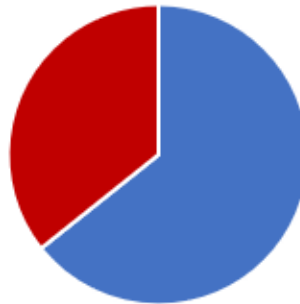


Question 11

- No - 5 (35.7%)

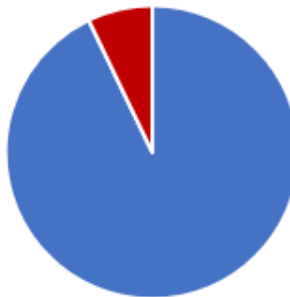


Question 12
