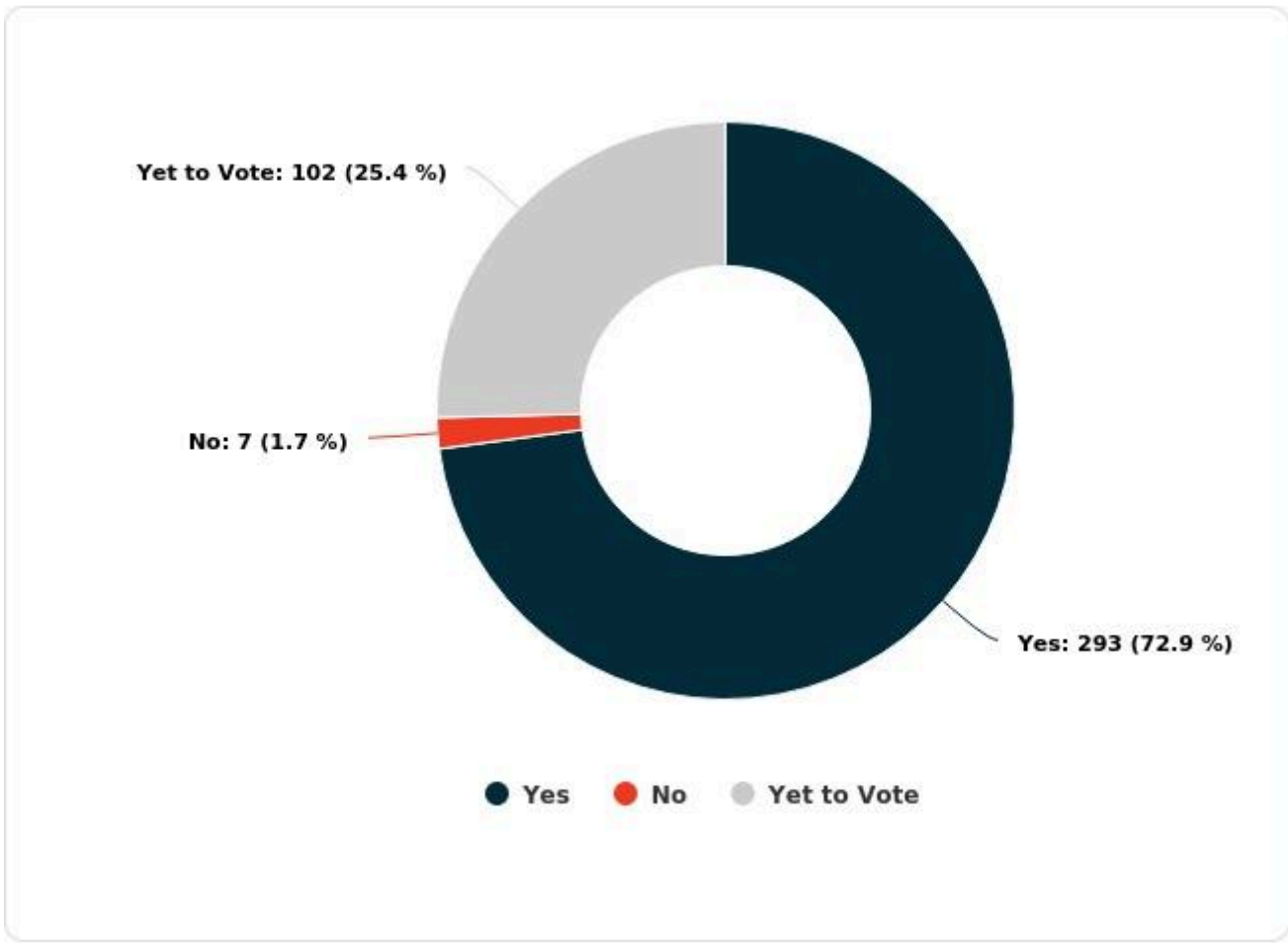
12. Employees only have Meal Breaks (Morning Tea, Lunch, Dinner and Afternoon Tea) in a Transgrid meal room?



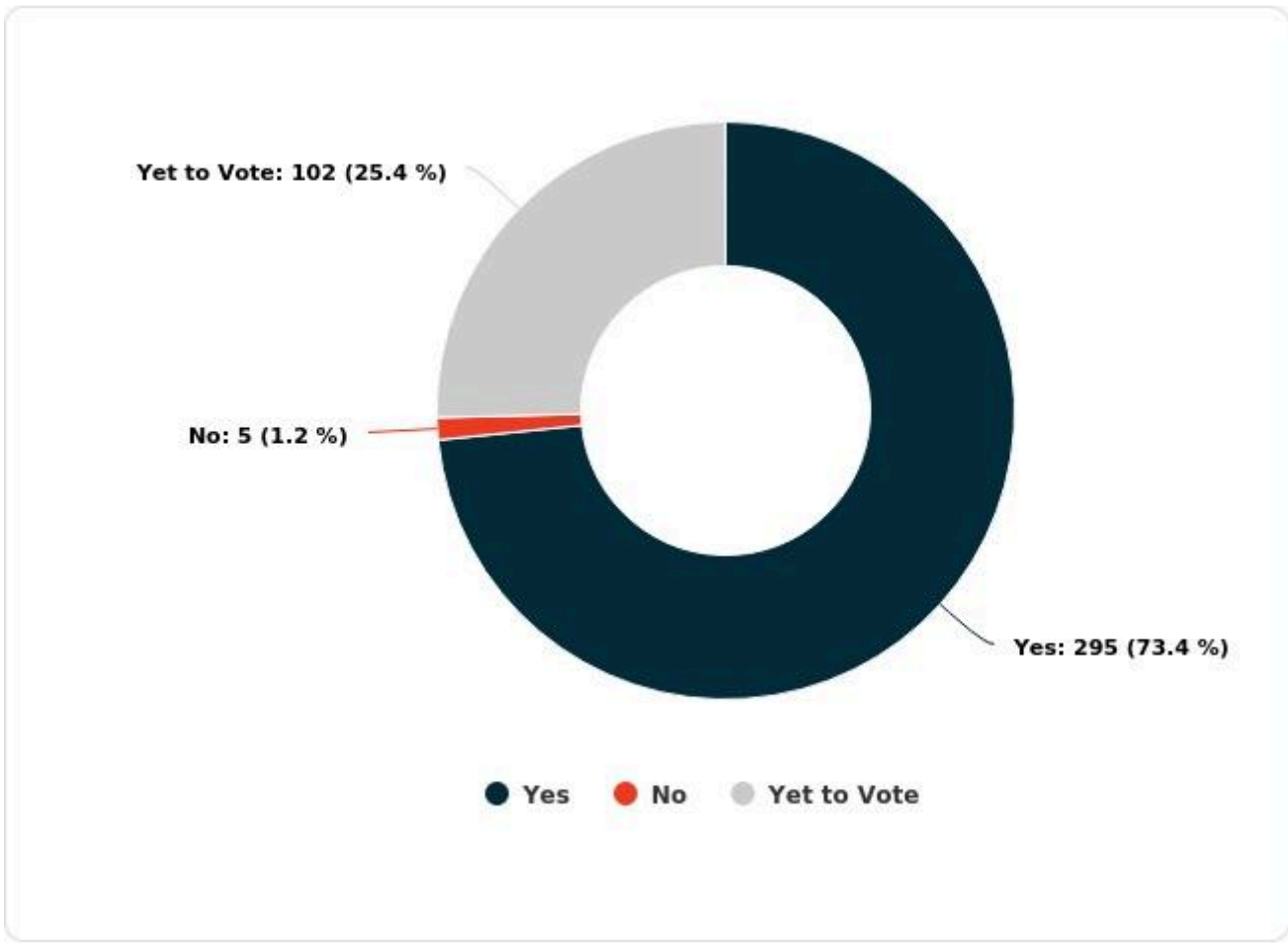

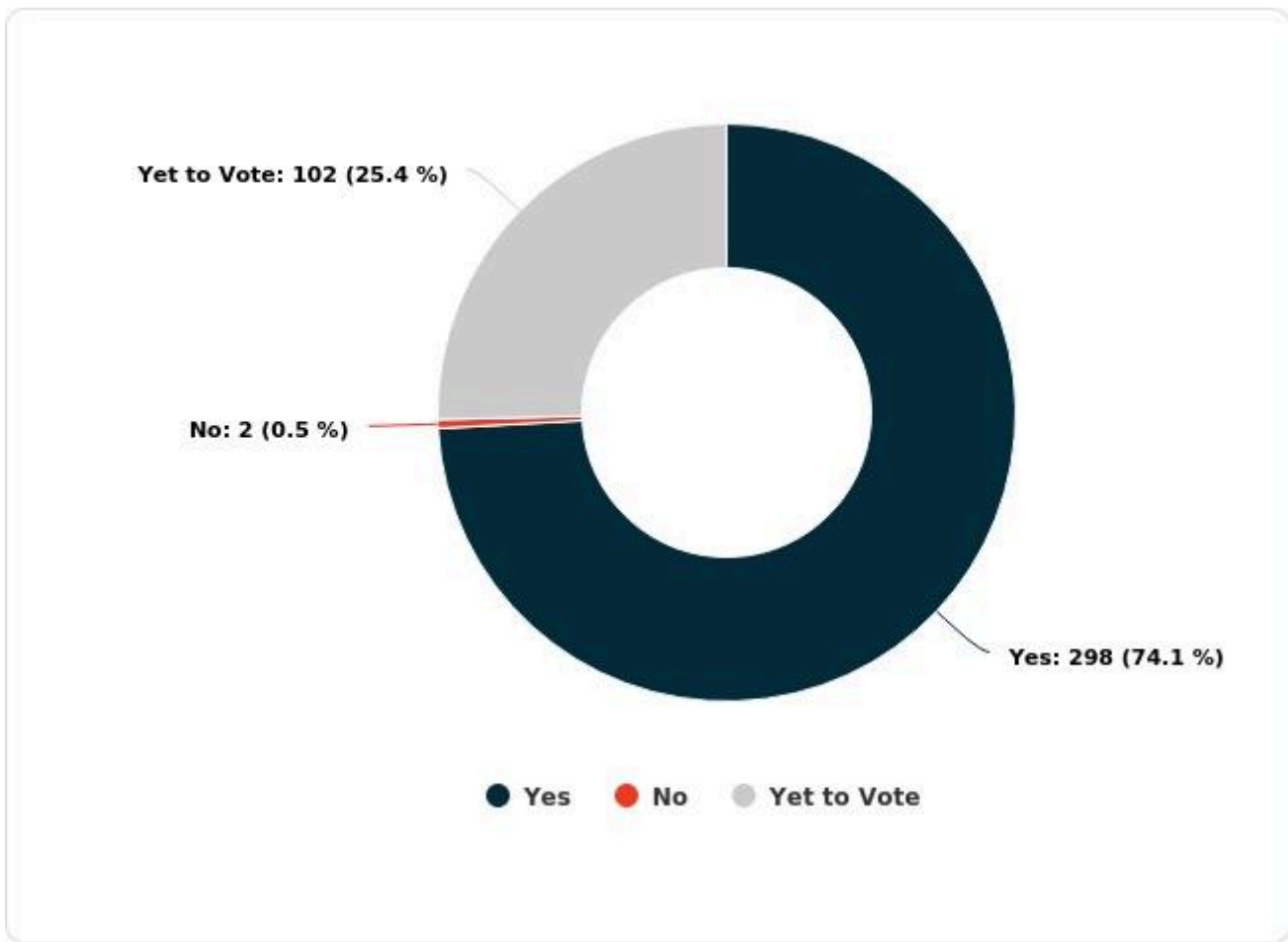
