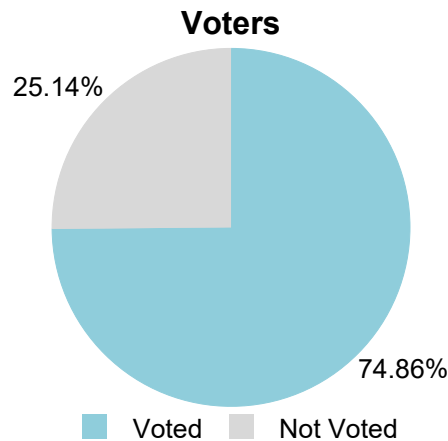

The following ballot report is for B2023/444 Protected Action Ballot conducted by TrueVote on behalf of National Tertiary Education Union NTEU. The ballot was live from 24/5/23 9:00 AM AEST to 2/6/23 4:00 PM AEST.

Voter Roll

The voter roll for the ballot consisted of 708 registered voters. 530 voters responded to the ballot notification sent out by TrueVote.

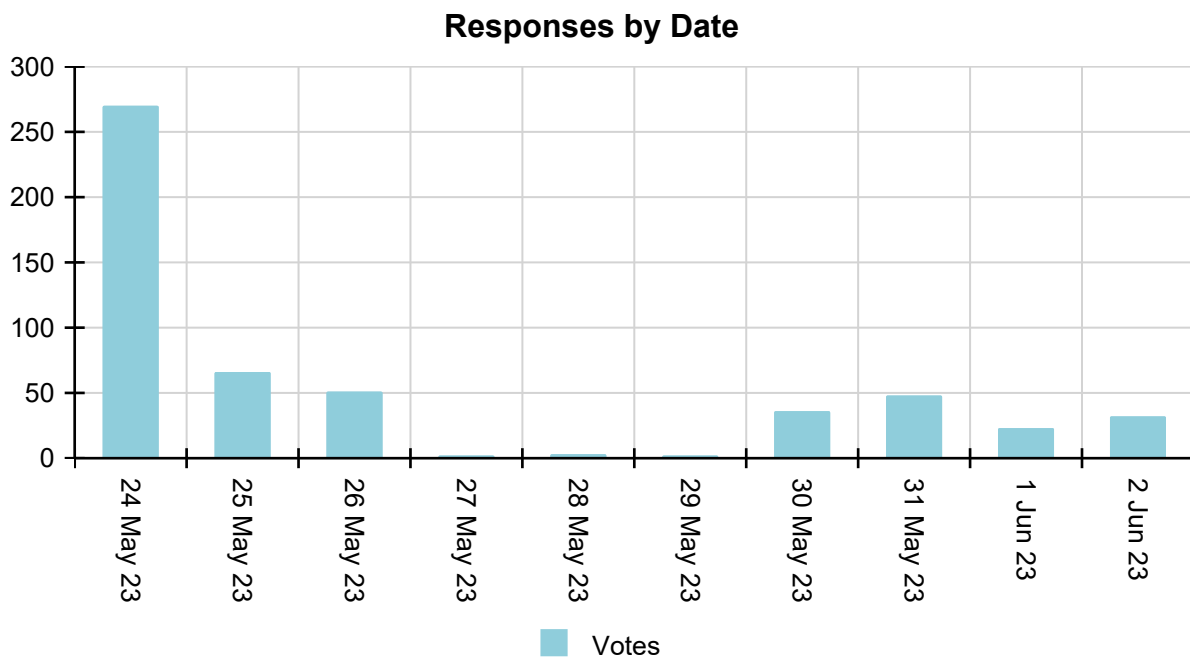
