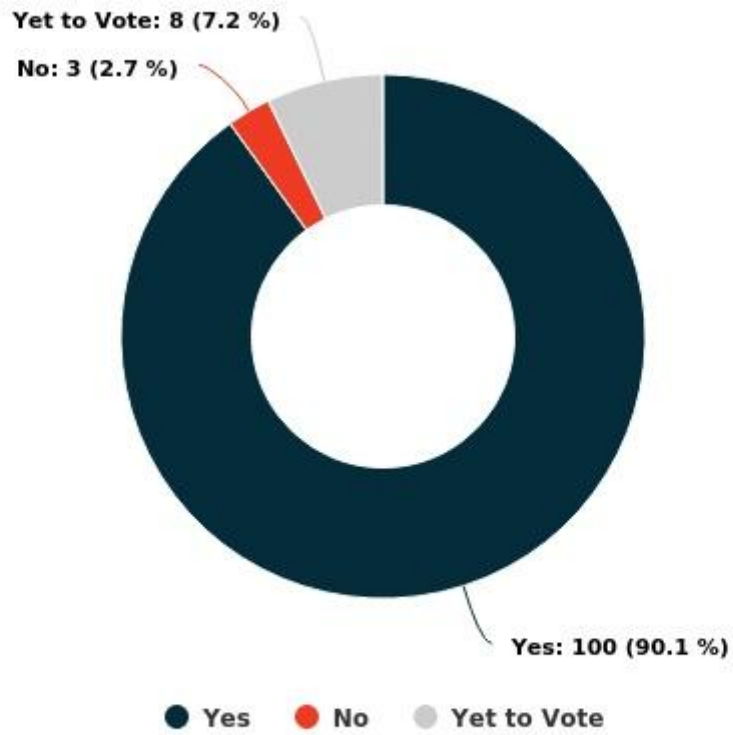

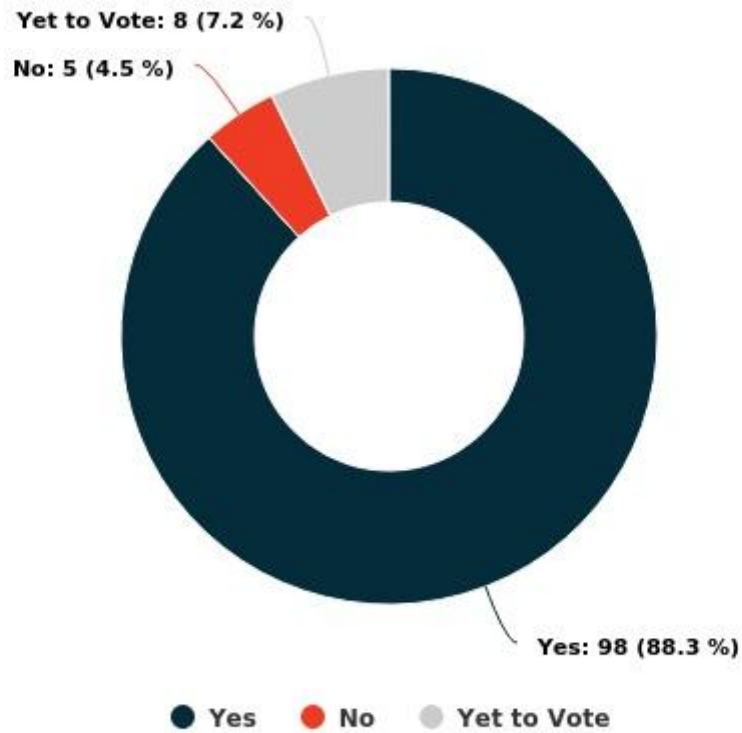

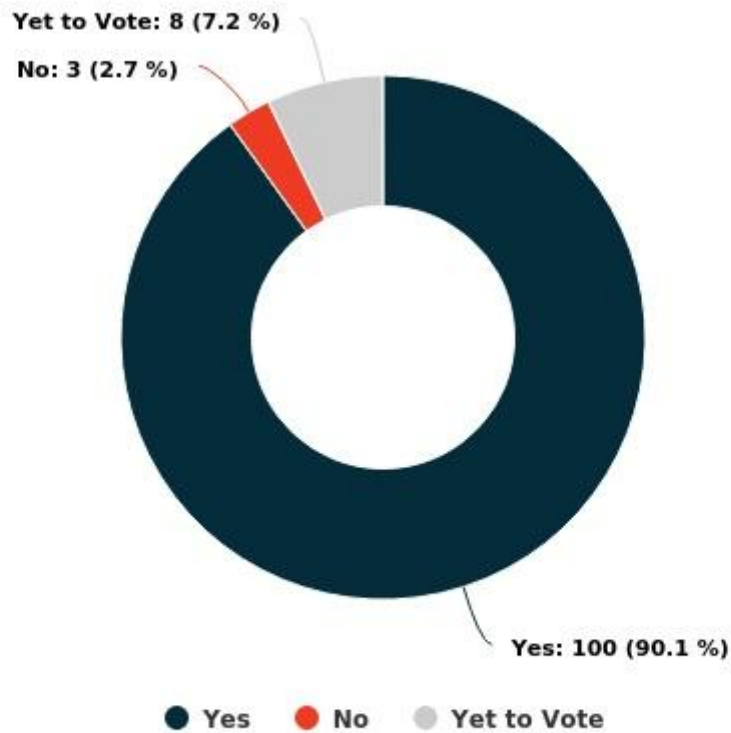
3. INDEFINITE OR PERIODIC BANS ON THE PERFORMANCE OF CHARTING TRAMS?



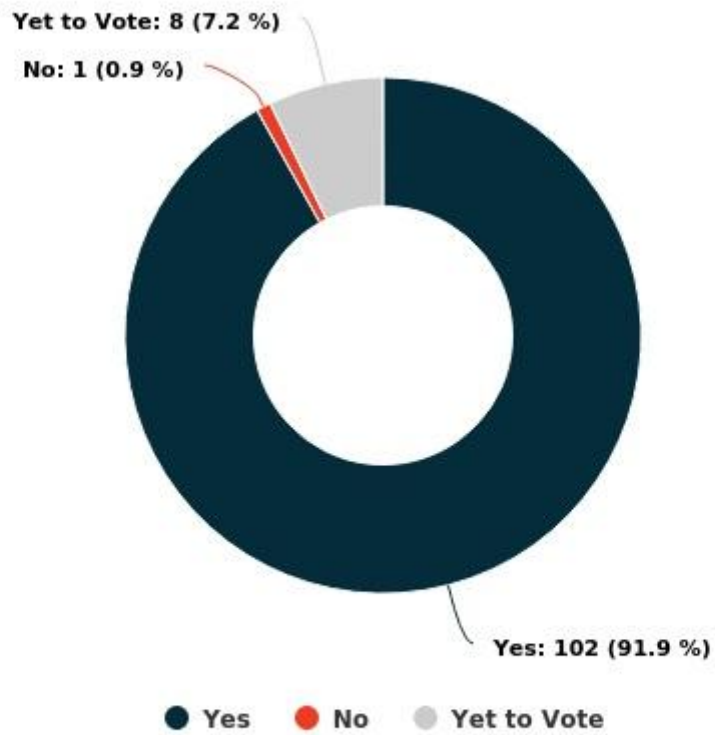
4. INDEFINITE OR PERIODIC BANS ON THE PERFORMANCE OF OVERTIME?



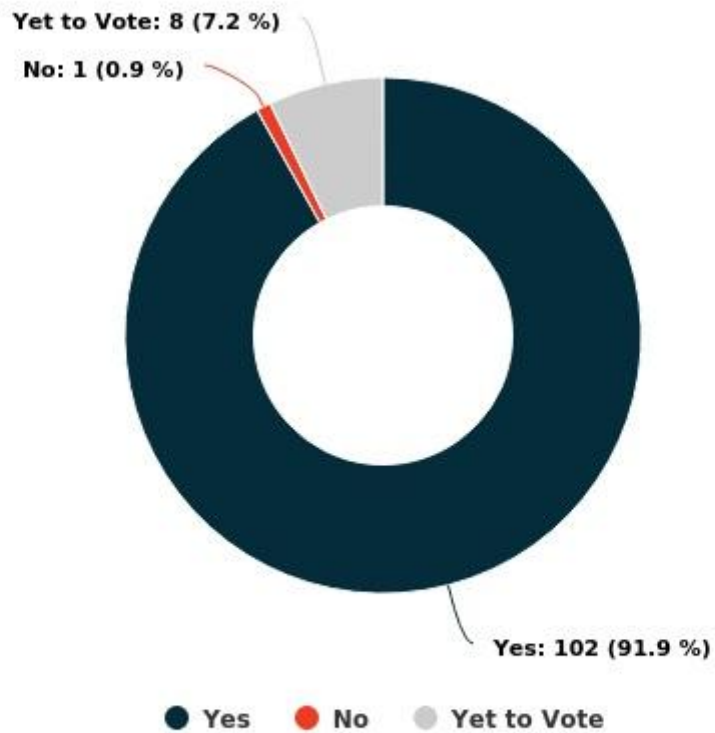

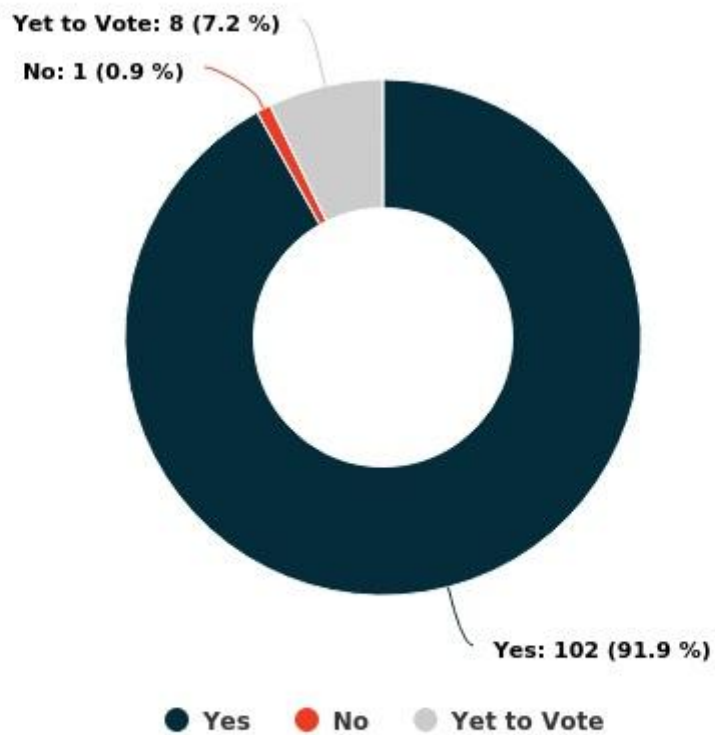

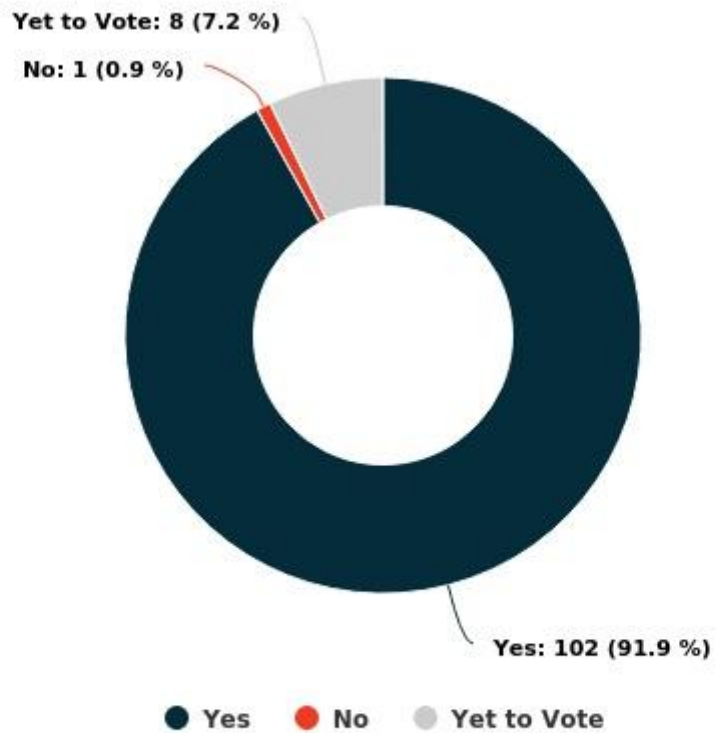
