Request for advice from the Road Transport Advisory Group subcommittee established for the purpose of consultation about applications for an employee-like minimum standards order and a road transport minimum standards order relating to 'last mile delivery' (MS2024/1 and MS2024/2)

I write to you both in your capacity as Joint Chairs of the subcommittee established by the Road Transport Advisory Group (RTAG) to consult with persons and organisations who may be affected by the orders sought in applications by the Transport Workers' Union of Australia (TWU) for an employee-like minimum standards order and a road transport minimum standards order relating to 'last mile delivery' (cases MS2024/1 and MS2024/2 respectively).

As you are aware, in its <u>Response to Directions issued by the President of the Fair Work Commission</u> (Commission) of 11 December 2024, the RTAG advised the President that it proposes a period of six months be allowed for consultation at the subcommittee level. During this time, the RTAG will monitor the progress of consultation, and will conduct a review of the effectiveness of consultation and the likelihood of consensus being reached in relation to applications and issues, at the end of the initial six-month period.

In a <u>Statement [2025] FWC 216</u> issued on 22 January 2025, the President reviewed submissions made about the RTAG Response of 11 December 2024 and confirmed the Commission's acceptance and adoption of the RTAG advice as to priorities and the consultation process in relation to the applications. The President directed the RTAG to commence a consultation process in relation to various applications, including the applications in MS2024/1 and MS2024/2. He further directed the RTAG to provide written advice as to the prioritisation of the matters once the RTAG has formed a final view.

I am aware that the subcommittee considering the two applications first met on 28 February 2025 and that the subcommittee adopted the <u>Guiding Principles for Subcommittees at Attachment A to the RTAG Terms of Reference</u>. To date, the subcommittee has met twice to consult about the TWU applications prior to formulating its advice to the RTAG about the applications.

Consistent with this role, I request that the subcommittee provide the RTAG with advice about the following in relation to the applications in MS2024/1 and MS2024/2:

- matters that are agreed
- matters that may be agreed
- matters that cannot be agreed and need to be determined
- the views of the subcommittee on the prioritisation of these applications in relation to other applications referred by the President to RTAG, and
- any other matters concerning the applications that the subcommittee considers relevant.

The RTAG Secretariat will be available to assist in preparing the advice.

Consistent with the RTAG's Response to the President, I request that the subcommittee provide its advice to the RTAG by no later than **28 August 2025 (being six months from the date of its first meeting).** Of course, if you consider the subcommittee can satisfactorily conclude consultation prior to that date, I would welcome its earlier advice,

I am aware that the next meeting of the subcommittee is on 4 April 2025 and I would appreciate you tabling this request. I have provided the request in advance of the date by which the advice is sought, to assist the subcommittee with its deliberations. I look forward to receiving the subcommittee's advice in due course.
