Dear Associate

We act for the entities in the DP World and Qube Ports groups (**Stevedoring Employers**).

We refer to the draft timetable in this matter (attached to the directions issued on 9 March 2016), which requires the filing of submissions in reply to the proponents' submissions by 5 August 2016.

As previously advised, the Stevedoring Employers have an interest in the proceedings as they oppose the ACTU's claims to vary the *Stevedoring Industry Award 2010*, and intend to file final written submissions in reply to the ACTU's submissions and to address the Commission's Issues Paper in this matter. However, as the ACTU submissions were filed only on 20 June 2016 (pursuant to the directions issued on 9 March 2016, they were originally due on 10 June 2016), it is not anticipated that the response submissions will be able to be filed by 5 August 2016. As such, consistent with the extension sought by and granted to the ACTU to file its submissions, the Stevedoring Employers respectfully request that the Full Bench allow a one week extension of time to 12 August 2016 to file their submissions in response.
