Airport Employees Award 2010 [MA000049] – minimum engagement and casual conversion

- 3. The SDA supports the draft determination published in respect of the minimum engagement for casual employees.
- 4. The SDA supports the draft determination published in respect of casual conversion.

Fast Food Industry Award 2010 [MA000003]

- 5. The SDA supports the draft determination published in respect of casual conversion.
- 6. We note that the part-time employment provisions of this award are currently the subject of proceedings before President Ross in Matter AM2017/49 Should there be a variation to the award determined in that matter, we note that the cross-reference at proposed subclause 13.5(j)(ii) may need to be adjusted accordingly. The SDA submits that no change is required for the time being.

- 13. The SDA notes, for the sake of consistency, that the cross-reference at proposed subclause 11.5(j)(ii) refers to the relevant part-timer provisions at "clause 11.3(c) and (d)". Clause 11.3(d) of the current award addresses:

"Any agreed variation to the regular pattern of work will be recorded in writing."

14. The SDA has no specific objection to including this cross-reference, but notes that other draft determinations reviewed, referred to above and below, do not pick up this specific subclause cross-reference. The SDA respectfully suggests that clause 11.3(d) of the award goes to a 'future' agreed variation rather than addressing the initial agreed terms of part-time engagement under clause 11.3(c). Clause 11.3(c) would apply as a matter of course once the terms of the initial part-time engagement have been agreed and commenced.
