On 25 April 2016 the HSU sent Commissioner Roe a proposed package as a resolution to the group of issues that have been under extensive discussion by the parties to the Review of the Health Professionals and Support Services Award 2010 for some time

Commissioner Roe kindly attached to his Further Report to the Full Bench dated 26 April 2016, which is now published, with a request that parties '**advise by no later than 3 May 2016 their response to the HSU proposal and to advise what matters, if any, in this**

**group of issues they continue to press as a result. The responses will be published on the website.'**

Commissioner Roe in his Report of 26 April 2016 commented on page 1

**'3. There are a number of outstanding items which should be referred to a Full Bench and which are likely to require the hearing of evidence. These items are:**

**a. Items 5A, 20B, 30A, 36A and 44 - Proposal for medical imaging appendix (note some of these items may be resolved by the HSU proposal). MIERG to update the status of these items in their response to the HSU proposals.)'**

To enable MIERG to respond on the MIERG specific and all the other HSU proposals with further consultation and consideration by private medical imaging practices we request additional time to consult fully with the practices.

MIERG therefore respectfully requests an extension of time to 24 May 2016 in which to provide a detailed response to the requests that affect private medical imaging in the Further Report to the Full Bench by Commissioner Roe of 26 April 2016
