Dear Associate,

I refer to the above matters, and the Conference of 09 August 2016 before Deputy President Clancy.

During that Conference, parties were directed to report back by 23 August 2016 regarding a coverage claim by Aussie Aquatics for the *Fitness Industry Award*, and the outstanding issues relating to ordinary hours and overtime for casual employees in both awards. Aussie Aquatics have circulated proposed wording for their claim, and parties have convened for a Teleconference on 18 August.

The AWU has undertaken to provide a summary in relation to these outstanding items for the purpose of a report back. At this stage the AWU is only capable of providing an interim summary, as some parties are still seeking instructions.

The AWU respectfully request an extension to report back by Monday 28 August in order to provide a summary that better reflects the parties final positions.

Please note this date has been suggested to parties late this afternoon, and as such it is the AWU's request. All parties have not had the opportunity to comment on this proposal. I note that Aussie Aquatics support this course of action.
