**AM2014/251 – Aged Care Award 2010**

I refer to the four yearly review in relation to the Aged Care Award 2010 (Aged Care Award) and to the Directions issued by His Honour Justice Ross on 26 August 2016.


Paragraph 1 of these Directions requires each interested party to file a short submission confirming the substantive claims being pursued on or before 4pm on Friday 30 September 2016.

Relevant to proceedings in the Aged Care Award are the current proceedings in the Social, Community, Home Care and Disability Services Award 2010 (SCHCDS Award) where the parties are currently participating in a series of conferences, which has the potential to significantly reduce the number of proposed variations and to narrow the issues in dispute.

As a number of applications in the Aged Care Award are similar to claims currently being discussed in the SCHCDS Award conferences, there is the potential that the outcome of these conferences may also reduce the number of proposed variations and narrow the issues in dispute in the Aged Care Award.

To assist the Commission efficiently allocate resources for the Aged Care Award four yearly review hearing, we respectfully request, with the consent of organisations pursuing applications in the Aged Care Award, that paragraph 1 of the Directions made by His Honour Justice Ross on 26 August 2016 in relation to the Aged Care Award be suspended until the conclusion of the conciliation process in the SCHCDS Award.
