#### Introduction

- 1. On 19 April 2018 the Australian Manufacturing Workers' Union **(AMWU)** filed a submission **(the April 19 Submission)**<sup>1</sup> in relation to the updated Exposure Draft of the Airline Operations Ground Staff Award and the Group 4 technical and drafting Decision.<sup>2</sup>
- 2. The AMWU now makes this brief supplementary submission to correct one element of the 19 April Submission in relation clause 11.2 of the Exposure Draft (items 10 and 11 of the summary of submissions).

### Items 10 and 11 - Casual Employment

- 3. Whilst the AMWU maintains the position expressed at paragraphs [5]-[12] of the April 19 Submission, the AMWU would like to make a slight amendment to the drafting proposed by the AMWU at paragraph [12].
- 4. In the April 19 Submission the AMWU proposed the following amendment to the Exposure Draft:

"For working ordinary time, a casual employee must be paid:

- (a) the ordinary hourly rate for the work being performed; plus
- (b) A loading of 25% of the ordinary hourly rate,

for the classification in which they are employed."

- 5. The AMWU withdraws that part of the April 19 submission and instead proposes the following:
  - 11.2 "A casual employee must be paid:
    - (a) the ordinary hourly rate for the work being performed; plus
    - (b) A loading of 25% of the ordinary hourly rate,

for the classification in which they are employed. This loading is instead of entitlements to leave and other matters from which casuals are excluded by the terms of this award and the NES.

6. The reason for the amendment is that the previous drafting was erroneous in that it incorrectly limited payment of the casual loading to instances when a casual employee is "working ordinary time." This was not the intention of the proposed drafting put forward by the AMWU.

7. Clearly casual employees covered by the *Airline Operations Ground Staff Award 2010* are entitled to receive a casual loading for all hours worked, as is correctly identified in the wage rate tables in schedule B of the Exposure Draft.
