Dear Justice Ross,

Re. AM2014/75 Manufacturing and Associated Industries and Occupations Award 2010; AM2014/203 Graphic Arts, Printing and Publishing Award 2010 and AM2014/268 Food, Beverage and Tobacco Manufacturing Award 2010 – Training Costs

We refer to the above matters.

On 28 April 2016, Ai Group filed correspondence and draft determinations regarding our claim to vary the *Manufacturing and Associated Industries and Occupations Award 2010* (Manufacturing Award) and the *Graphic Arts, Printing and Publishing Award 2010* (Graphic Arts Award) in respect of 'training costs'. Our claim was subsequently listed for mention before Your Honour on 13 May 2016.

During the aforementioned proceedings, Ai Group identified that the relevant issue that we seek to address in the Manufacturing Award and the Graphic Arts Award also arises in the Food, Beverage and Tobacco Manufacturing Award 2010 (FBT Award), and we indicated that we intend to pursue a similar variation to that award. Your Honour directed Ai Group to file a draft determination that identifies the terms of the variation sought by 16 May 2016.

Accordingly, please find attached a draft determination in respect of the FBT Award. As we indicated during the aforementioned proceedings, we consider that this claim should be dealt with in conjunction with our proposal to vary the Manufacturing Award and Graphic Arts Award.
