4 YEARLY REVIEW OF MODERN AWARDS- SUPPORTED EMPLOYMENT SERVICES AWARD 2010 (AM2014/286)

- 1. We refer to the Schedule issued by Vice President Hatcher's Chambers on 22 January 2018 requiring parties in the abovementioned proceedings to file objections to evidence no later than 4pm on 6 February 2018.
- 2. We outline below the position of our clients in relation to the evidence filed by AED Legal.

General Observation as to Evidence

- 3. In reviewing the materials filed by AED Legal, our clients are mindful of the practice of the Fair Work Commission in 4 Yearly Review proceedings to avoid taking an overly technical approach to the admissibility of evidence.
- 4. As such, our clients are content to refrain from taking a technical approach to evidentiary objections and are comfortable that the Full Bench will make its own assessment as to the weight to be afforded to the witness evidence, particularly in relation to relevance and matters of opinion.
- 5. Notwithstanding this general approach, we take this opportunity to make a number of specific observations in respect of the witness evidence of Mr Paul Cain and Mr Robert Macfarlane below.

Opinion Evidence

6. The evidence of Mr Cain and Mr Macfarlane appears to be brought as 'expert opinion evidence', that is, evidence of an opinion held by the witness that is wholly or substantially based on the specialised knowledge of that witness.

- 7. Despite this, and contrary to the custom in Fair Work Commission proceedings involving 'expert witnesses', neither Mr Cain nor Mr Macfarlane make reference to, nor do they appear to have complied with, the Federal Court of Australia's Expert Evidence Practice Note (GPN-EXPT) (**Practice Note**).
- 8. As a threshold issue, it is not clear that Mr Cain or Mr Macfarlane have specialised knowledge based on their training, study or experience in relation to all matters that their statements go to.
- 9. A further practical difficulty arises for our clients in that in various parts of their statements, Mr Cain and Mr Macfarlane do not outline the assumptions and material facts on which their opinions are based.
- 10. In order to assist the Full Bench, we outline in the below table the specific paragraphs at which we submit Mr Cain and Mr Macfarlane make statements of opinion, which are not appropriately supported, or otherwise are merely matters of submission.
- 11. These paragraphs are of limited probative value and accordingly should be afforded limited weight.
