not oppose the removal of the minimum wage rates **for junior apprentices** commencing or continuing an apprenticeship prior to 1 January 2014 contained in clauses 11.9 (b) and 11.10 (b).

(emphasis added)

Clause 11.9(b) deals with junior apprentices but clause 11.10(b) deals with adult apprentices commencing before 1 January 2014.

Could you please confirm by return email that you have no objection to the removal of the adult rates as well. On receipt of this information the Commission will re0issue a draft clauses in relation to apprenticeship rates.
