## **AM2015/2 FAMILY FRIENDLY WORK ARRANGEMENTS**

- 1.1 We refer to the recent correspondence between the ACTU, Ai Group and the Fair Work Commission on 20 and 21 November 2017 regarding the identification of witnesses required for cross-examination during the hearing of these proceedings commencing 12 December 2017.
