## Alpine Resorts Award 2010 (AM2016/30)

We refer to the objections made by the Mount Hotham Resort Management Board, and Australian Business Industrial/New South Wales Business Chamber/Thredbo Chamber of Commerce ("together ABI") to certain aspects of the witness statement of Gavin Girling.

Without exception, the objections are technicalities, going to form rather than substance and based on legal issues such as whether the evidence is hearsay, or a conclusion, or a submission.

Firstly, we, would point out, in accordance with section 591 of the *Fair Work Act 2009* (Cth) ("Act"), the Fair Work Commission ("Commission") is not bound by the rules of evidence. Further and more significantly, section 577(b) of the Act directs the Commission to exercise its powers in a manner that "is quick, informal and avoids unnecessary technicalities". These technical objections can all be resolved without the need for legal arguments on technical points by the Commission dealing with the issues as they arise in evidence and giving the evidence the necessary weight (or no weight at all, if that was appropriate).

In summary, the Australian Ski Areas Association maintains its original position, as set out in our email dated 19 October 2017, that any evidentiary issues can be resolved through cross examination and submissions on weight.
