#### AM2016/30 Alpine Resorts Award

You will recall we act for the Australian Ski Areas Association ("**Association**") in relation to the above matter.

We refer to your email of 18 October 2017 which confirmed the Full Bench had determined not to make the Orders sought pursuant to our earlier application for the production of documents ("Form F52 Application").

While we respectfully accept the Full Bench's decision, we are nonetheless concerned to correct two specific inaccuracies included in the submission filed by ABL objecting to our Form F52 Application ("**Submission**"). Specifically:

- a. At paragraph 2.3 of the Submission, ABL submits "...only one witness has stated that the Award coverage was preventing the witness from 'growing' their business...". In fact, eleven of ABL's twelve employer witnesses make express reference in their statement to the alleged commercial disadvantage they experience as a result of being covered by Awards other than Alpine Resorts Award 2010.
- b. At paragraph 3.5 of the Submission, ABL submits that the Form F52 Application seeks Orders for the production of "...<u>all advice</u> from accountants, bookkeepers and associations of employers" (emphasis ABL's). This submission is demonstrably incorrect, and the draft Order attached to the Form 52 Application properly and appropriately prescribed the range of Documents sought.

As the Association was not afforded an opportunity to respond to ABL's Submission before a final decision was made, we respectfully attach for the Full Bench's reference a copy of the Outline of Submissions we had intended to rely upon had such an opportunity been provided.

Finally, given the Full Bench's observations regarding the earlier Form F52 Application, we now attach a fresh Form F52 Application for the Commission's earliest possible consideration.

#### Outline of Submissions in Support of Form F52 Application for Orders to Produce

- We refer to the 12 Form F52 Applications for Orders for the Production of Documents that were filed in the above matter on 10 and 12 October 2017, and the subsequent objections raised to those Applications by Australian Business Lawyers & Advisors ("ABL") on behalf of the Australian Business Industrial/the NSW Business Chamber Ltd/Thredbo Chamber of Commerce.
- 2. As correctly noted by ABL, "the question posed by these proceedings is: what is the appropriate scope of the coverage clause in this Award"?
- 3. Of ABL's twelve witnesses, eleven make express reference to the alleged commercial disadvantage they experience as a result of being covered by Awards other than the Alpine Resorts Award 2010 in their witness statement:

#### a) Narelle Clark

- (p26) "Given I do so much of the housekeeping work myself (because the weekend penalty rates are so high) it is a challenge to find time to spend on marketing and growing CWA".
- (p27) "I find it very difficult to grow the business and employ more staff because of the high cost of having staff work on weekends. I would prefer to employ more staff on a Saturday, and particularly on a Sunday given all the changeovers, but I cannot afford the wages."
- (p54) "All the private accommodation operators are in a similar situation to me, in that we are competing with Falls Creek SL for staff and are having a difficult time trying to build our business against a very large corporate entity that has a more favourable Modern Award."

#### b) Brett Williams

- (p37) "My personal view is that the alpine industry is not a level playing field."
- (p38) "The lift operators have the benefit of the Alpine Resorts Award 2010 which they hire all of their staff under, not just those working on ski lifts."

#### c) Sandra Connor

(p65) "Coupled with the fact KT engages its employees under the more favourable Alpine Resorts Award 2010, it is very difficult for private owners and operators in Thredbo to compete commercially on a level playing field."

#### d) Stephen Pennington

(p42) In my opinion it is totally incongruous that the various businesses within an Alpine Resort are required to treat their staff differently, and therefore can have the unintended effect that businesses within one resort are not competing on "an even playing field" from a staffing perspective."

#### e) Keith Archibald

- (p40) "I do get frustrated paying high penalty rates on a Sunday when it never feels like a Sunday in the Falls Creek Resort Village."
- (p44) "It would be very valuable to be able to improve services while saving on wage costs in the same way as the lift company...can as it engages its employees under the more suitable Alpine Resorts Award 2010."

#### f) Nick Cook

(pp 21 and 22) Notes he has no direct competitors, but Falls Creek Alpine Resort (covered by the Alpine Resorts Award 2010) sells takeaway food and chocolate bars, soft drinks and snack foods.

#### g) Ian Foster

- (p49) "It is common knowledge that Kosciusko Thredbo Pty Ltd owns and operates other businesses within the village, many of which operate in competition with the other private business owners in Thredbo."
- (p53) "The TAM service operated by the Thredbo Alpine Hotel is a direct competitor..."
- (p55) "I believe TAM employs its employees under the Alpine Resorts Award 2010."

#### h) Rob Aivatoglou

(p38) "My biggest competitor is Buller Ski Lifts (BSL)..."

(p40) BSL has a high volume rental set up and the only way I can compete to keep my business running is by hiring more staff and providing a specialized level of service."

(41) Given I have all of my employees working on a Sunday, this significantly impacts on the level of penalty rates I need to pay under the Retail Award for each employee to work that day."

#### i) Gregg Quinn

(p40) "All the private business operators at Thredbo are well aware that KT (Kosciusko Thredbo) owns and operates other business (sic) within the village and many of KT's businesses operate in competition with the private business owners."

#### j) Steve Owen

(p20) "In a small village such as Thredbo, any business which offers food or drinks is a competitor of ours, including grocery stores. This includes all of the restaurants, cafes, and bars in the village, including resort-owned establishments..."

#### k) John Leggett

- (22) "...I have always wondered about the uneven playing field in these cases where the same tasks are taken on one year afte the next with a change under two completely different awards and have always considered a different bottom line of wages expenses at the end of each season for the same task.
- 4. It is disingenuous for ABL to, on the one hand, submit that "...awareness of Alpine Tourism Businesses of the industrial and competitive environment that they were entering into does not help the Commission determine: what should be the industry that is regulated by the Award" while, on the hand submitting eleven witness statements which lament the same industrial and competitive environment.
- 5. As ABL correctly acknowledges, documents sought by a party pursuant to an Order to Produce must be relevant to the proceedings. However, we note they need not be 'directly relevant' and that an 'apparent relevance' is generally sufficient. Given the overwhelming majority of ABL's witnesses specifically refer to the industrial and competitive environment within which they operate and given the long and well-documented history of Award coverage in the relevant industries and occupations and

the presumably clear exigencies involved in running a business in an alpine area - it is both relevant and appropriate for the Commission to Order production of the documents requested.

- 6. It is well-established that the range of documents sought must be specified with reasonable particularity.<sup>4</sup> All of the documentation sought by ASAA has been particularised, and is comprised of records the witnesses should be easily able to ascertain. We comprehensively reject ABL's submission that production of the documents requested would amount to a form of 'harassment'.
- 7. For the avoidance of doubt, ABL's submission that the Draft Order requests production of 'all advice from accountants, bookkeepers, and associations of employers' is demonstrably incorrect. The relevant paragraph of the Draft Order has been properly prescribed and reads as follows (emphasis added):
  - "All Documents evidencing or recording all efforts made by the Respondent to further develop the Respondent's current business, including but not limited to
  - (iii) copies of requests for, and advice from, business development advisors such as marketing agencies, accountants and bookkeepers, and/or associations of employers..."
- 8. ABL's final submission that, in the event the Commission is minded to approve ASAA's application similar Orders should also be imposed upon ASAA's own members appears to have no ascertainable probative basis whatsoever. Instead, it appears to be a mere and quite inappropriate exercise in equivalent retaliation which should rightly be dismissed.
