RCI will continue to press the remainder of its claims – items 4, 6 and 9).

RCI will also not be pressing any of its claims in relation to the Hospitality Industry (General) Award 2010 – items 41-43 of the summary of proposed variations (<https://www.fwc.gov.au/documents/sites/awardsmodernfouryr/hospitality-substantive-issues-summary-subs-110118.pdf>) .

This will also mean that there will be a reduction in the of witnesses, in respect of the discontinued claims.
