We confirm that we act for the National Aboriginal and Torres Strait Islander Health Worker Association Limited (NATSIHWA) in the Proceedings.

The background to this correspondence is summarised below:

- 1 on 6 February 2019, Justice Ross, President issued a Statement which, amongst other things, indicated that a programming mention in relation to the Proceedings would be issued (**AM2018/12 Programming Mention**);
- 2 on 28 February 2019 Justice Ross, President issued a Statement which, amongst other things, scheduled a conference for 3 April 2019 *"to deal with any questions regarding the scheduling of proceedings and process for finalising the Review"* (Conference);
- 3 on 27 March 2019, NATSIHWA confirmed that it intended to request at the Conference that the **AM2018/12 Programming Mention** be listed;
- 4 on 28 March 2019, the Commission issued a notice of listing scheduling the **AM2018/12 Programming Mention** for 4 April 2019.


