- 1. There have been instances recently where an employer has put forward the view that, if the qualifications referred to in clause 16.2 are required by the Civil Aviation Safety Authority, then they are not required by the employer. Accordingly, it is argued that the employer is not responsible for those qualifications.
- The AFAP disagrees with this position, and says that such a position is unsupported by the history and terms of clause 16.2.
- 3. Should an ambiguity or an uncertainty be found to exist, the AFAP seeks the amendment to clarify the intended operation of clause 16.2.
- 4. This application is made pursuant to s.160 of the Fair Work Act 2009 (Cth) ("FW Act"). As the application is one to remove an ambiguity or uncertainty, it only seeks to clarify clause 16.2's intended meaning. The amendment sought will not derogate from the modern awards objective.
