I have had an exchange with each party either verbally or via email. On the basis of these conversations, I can report the following. Individual parties may wish to communicate with you directly in the event that I have not captured their position accurately. I note G8 has already responded to your message.

- (a) Each party has confirmed that none of the parties wish to cross examine any of the witnesses.
- (b) Some parties have expressed optimism that the hearing can be dealt with during the course of one day. Others are more sceptical, and predict that, depending on the extent to which the Commission may wish to engage with the participants particularly the Peak Councils it is likely the hearing will extend into at least part of the second day which has been set aside.
