Review of classification rates at the C14 and C13 level in modern awards – Wool Storage, Sampling and Testing Award 2020 – award varied.

A. Further to the decision issued by the Expert Panel on XX Month 2024 [[2024] FWCFB XX], the above award is varied as follows:

1. By deleting the row for Wool Industry Worker Level 1 (Wool Storage) in the table appearing in clause 16.1 and inserting the following:
