We refer to the Statement issued by the full bench in this matter on 22 September 2023 (**September Statement**) expanding the scope of the proceedings.

At paragraph [27] of the September Statement, the full bench set out the next steps in the proceedings, including at [27].1 the filing of material by interested parties by **Friday 3 November 2023**.

In these proceedings, the CFMMEU-Manufacturing Division (CFMMEU-MD) has an interest in the following modern awards listed in Attachment D to the September Statement:

- *Manufacturing and Associated Industries and Occupations Award 2020*
