We refer to the above matter and the Statement issued by the Justice Hatcher on 11 August 2025 ([2025] FWC 2328).

At paragraph [10], interested parties were invited to make any comments of a technical nature regarding the draft determinations by 12:00pm today.

On behalf of Ageing Australia one comment is made in relation to the draft determination for the *Aged Care Award 2010*. At paragraph 1, the proposed text for clause 14.3 refers to “*Aged care employee level 1*” at each classification level. This appears to be a typographical error. We respectfully submit that each reference to “*Aged care employee level 1*” should be replaced with “*Aged care employee*”.
