  2. By deleting the amount “\$13.79” appearing in clause 26.4(c) and inserting “\$13.95”.
  3. By deleting the amounts “\$1.82” and “\$8.92” appearing in clause 26.5(a) and inserting “\$1.86” and “\$9.11” respectively.
  4. By deleting the amount “\$0.78” appearing in clause 26.7(b) and inserting “\$0.85”.
  5. By deleting the amount “\$6.68” appearing in clause 26.11 and inserting “\$7.28”.
  6. By deleting the amount “\$8.34” appearing in clause 37.7 and inserting “\$8.44”.
  7. By deleting the table appearing in clause C.2.1 and inserting the following:
