  6. By deleting the amount “\$14.05” appearing in clause 17.6 and inserting “\$14.26”.
  7. By deleting the amount “\$373.43” appearing in clause 17.7(c)(ii) and inserting “\$389.73”.
  8. By deleting the amount “\$53.36” appearing in clause 17.7(c)(iii) and inserting “\$55.69”.
  9. By deleting the amounts “\$200.21” and “\$28.56” appearing in clause 17.7(d)(ii) and inserting “\$208.95” and “\$29.81” respectively.
  10. By deleting the amount “\$25.46” appearing in clause 17.7(g)(i) and inserting “\$26.12”.
